

# 該喝貓屎咖啡嗎?

#### 香港人

## Covid-19 + Omicron and Sunspot Theory: Subsiding by 2022

#### ABSTRACT

#### Background

COVID-19 is co-existing in the contemporary World. During the 2.2-year period (2020-1-1 to 2021-3-3) when the Covid-19 comes into play, the World has recorded around 440,553,000 cases, averaging 557,662/day. Death toll so far is around 5,993,000, with a mortality rate of 1.36% (compared to 1.95% till end-Nov 2021 when the Omicron Variant came into play). Dr. Angelique Coetee (Head of S. Africa Medical Association) has voiced recently that the symptom of the new variant Omicron is mild and there is no need for patients to be hospitalized. Yet, due to its fast propagation speed resulted from the 32 mutations on the Spike Protein and the 10 mutations on the 'receptor binding domain' which gain entry to the human cells, it has attracted global attention, and many countries have closed their borders to relevant regions.

#### Methods

This research paper is based on the impact of the consistent Sunspot cycle's 11-year variation on mankind. Riding on a similar paper published at the Oxford Business & Economic Conference in 2007 on a hypothesis of Sunspot on "Uni-Economic" which has been award the best paper at the time, the current paper is focusing on the impact of Sunspot, but on the front of human health as affected by the Covid-19 Pandemic. Dataset over 4 centuries and converging on the past 60 years have been collected to verify the hypothesis of Sunspot on Pandemic with confidence level above 95%.

#### Results

2019 experienced the lowest sunspot in the history of mankind at 281 days without any Sunspot. In other words, there is a subtle lack of "Energy" for mankind. It is well recognized that, in Tradition Chinese Medicine (TCM) theory, Energy (Chi) is the most important drive and defense line for our human body.

#### Conclusion

Through literature review and critical analysis, most of the Pandemic in the human history occurs at the Sunspot Minima years when there were serious lacking of Chi for mankind.
